As from January 2007, all litter or single puppy registrations must include the name of the affix in addition to the puppy/s names.

The main benefit of owning an affix is to identify any dogs owned or bred by the holder of the affix, but it also aids in the naming of litters, giving dogs which you have bred a unique name.

It is advisable to apply for the ownership of the affix in the same name as any dogs owned by the same person(s), as an affix can only be used in a dog's name where the ownership of the dog and the affix are the same.
